# A magnetic neighborhood play space for all abilities

#### **Project Overview**

Martin Luther King, Jr. Park is a signature historic park in Buffalo, New York designed by renowned landscape architect Frederick Law Olmsted in 1874. The park rose to the top in KABOOM!'s communityengaged project prioritization process for needing improvement, notably due to its aging equipment and lack of ADAaccessible pathways.

Prior to the renovation, MLK Jr. Park Playground was an already active site in need of capital investment. Rather than start from scratch on a separate site, the reconstruction project leveraged existing community familiarity with and ties to the site — with a slight site change to improve pathway accessibility. Today, the playground serves residents of adjacent neighborhoods and visitors from a wider area in search of accessible playground.



When we have community meetings, folks will comment on how much they appreciate being able to bring kids with special needs to the site. In the past, they would have to drive out to the suburbs.

At the same time that the playground was identified in the Conservancy's 5-year plan as a place that needed improvement, KABOOM! approached the Conservancy with the grant opportunity. The old playground had outdated equipment and no accessible pathways

#### DESIGN AND CONSTRUCTION -BREAKING NEW GROUND IN BUFFALO

The new playground was designed with features for kids of all abilities. By relocating it closer to existing paths and picnic structures, the space today is more easily accessible and comfortable to use. The Conservancy overcame construction challenges on Build Day and today is proud to have led volunteers in building the city's first accessible playground.

#### COMMUNITY PARTICIPATION – TO CENTER COMMUNITY DESIRES

KABOOM! helped implement a fully inperson community engagement process in collaboration with the nearby Buffalo Museum of Science and a local public school. Engagement included small focus groups of parents and current playground users, design sessions with kids and families to dream up future park features, and outreach through community groups and religious institutions. KABOOM! staff facilitated engagement with support from the Olmsted Parks Conservancy, helping translate kids' bold ideas into feasible playground features.

#### Prioritize beloved community spaces in need of investment.

Leverage existing community relations to and association with specific sites and their surroundings rather than forging these from scratch.

# Consider activity at the playground's edge.

Adjacent amenities that provide basic comforts like shade and water can enhance the overall playground experience for kids and guardians alike, and extend and complement playground use, providing a place to watch, rest, and refresh.
